# Proclamation of Nation State - Amendment: Nationen Danmark

Established autumn Two Thousand and Twenty Two



## Preamble

For the sake of justice and truth for the whole Nation of Denmark, this Proclamation of a Sovereign Nation State by the name: Nationen Danmark has been established by the de jure government of the people of The Nation of Denmark: Council of the Seven Acephali as the only real remedy to counter the crimes against humanity and the Trust ex maleficio by KINGDOM OF DENMARK, CIK NO. #0000028095, the de facto state and commercial administrator of Slotsholmen and not the Nation lands known to the world as Denmark. Both the Ministry of Foreign Affairs and Justice Department of KINGDOM OF DENMARK has in writing clearly stated that they only have jurisdiction 200 nautic miles outside the land known as Denmark; hence a claim to territory is a fiction. KINGDOM OF DENMARK is but the island known as Slotsholmen - nothing else. This Proclamation of Nation State - corrects that administrative error.

## Hear yeh hear yeh all!

We, the free natural-born men and women of the land known as Denmark, hereby and herewith Proclaim that our Nation of Denmark has been reborn! No man, commercial entity, beast, person nor ruler can dispute this. We so do create our state as a special purpose vehicle, for the sake of interacting with other sovereign states in commerce and trade. We claim the lands of our forefathers namely: The land known as Denmark clearly described as the peninsula Jylland, the islands; Sjælland, Fyn, Lolland, Falster, Møn, Bornholm, Samsø, Læsø, Anholt, Mors, Fanø, Rømø, Als, Langeland, Ærø, Tåsinge, Vendsyssel and all other named islands, small islands, islets, and archipelagos, as well as underwater areas and with associated continental shelves, landmasses to the core of the Earth, inner and outer waters, and from the Earth to the Firmament. From now on, this is collectively called: Denmark. The island: Slotsholmen excluded. We hereby declare all other claims null and void.

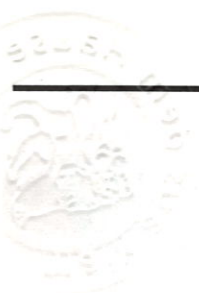
## Nation State structure:

2. Decentralized Government. The state administration comprises a number of small local councils.
3. Landmass: Land of Denmark.
4. Army: We have no commercial armed forces.
5. Currency: Eco (silverbacked) digital.
6. Court system: Folkedomstolen.
7. Constitution: Declaration of Sovereignty for The Nation of Denmark.
8. Flag name: Danebro.
